- There is no obligation to grant an award each year and there may well be several years between awards.
- Nominations may only be made by individuals who personally know the candidate well, or who are very familiar with the candidate's contribution to the GA sector.

- provide consistent and innovative value to the sector and to the aviation industry in Australia
- contribute to the growth and development of the sector in significant and identifiable ways.
- have contributed in some specific way to the advancement of general aviation in the past 12 months
- meet all aviation and corporate regulatory and operational requirements to the highest standards.

PROCESS

- There will be only one recipient each year.
- There is no obligation to grant an award each year and there may well be several years between awards.
- Nominations may only be made by individuals who personally know the aero club, or who are very familiar with the club's contribution to the GA sector.
- Self-nomination is acceptable.
- Once agreed, *Australian Flying* will discuss the award with the candidate to ensure they agree with the granting of the award. If so then it will be announced. If not, the matter is closed.

JUDGING CRITERIA

What we are looking for

- The award is granted for exemplary service in the past 12 months but will take into consideration the candidate's contribution over longer periods of time.
- The decision will be based on a pragmatic review of the contribution by the candidate beyond the norm and the respect with which they are held by their peers.

PROCESS

- There will be only one recipient each year.
- There is no obligation to grant an award each year and there may well be several years between awards.
- Where the recipient has served as a member of a group or team that team may be recognised but only the recipient will be granted the award.
- Nominations may only be made by individuals who personally know the candidate well, or who are very familiar with the candidate's contribution to the GA flying training sector.
- Self-nomination is acceptable.
- Once agreed, *Australian Flying* will discuss the award with the candidate to ensure they agree with the granting of the award. If so then it will be announced. If not, the matter is closed.
- The award may be revoked at the discretion of the organisers.
